At the time that irrigation is desired, it will be required that the customer installs a meter and use of an applicable rate will be determined at that time. Service under this rate is normally discontinued at the time of a final inspection by the City Plumbing Inspector. This rate may be assessed or discontinued at the option of CFU.
